### 1.0 Purpose

To define the supplier performance rating scorecard and establish purchasing guidelines based on supplier performance.

### 2.0 Scope

This procedure applies to Velvac direct material suppliers.

### 3.0 Responsibility

It is the responsibility of the Sourcing Team to review supplier performance and follow the guidelines laid out in this procedure. It is the responsibility of the Supply Chain Management Director to authorize this process and to review all changes.

### 4.0 Procedure

- 4.1 Velvac's Supplier Performance Scorecard is one of the key metrics used to measure supplier's performance. It is composed of two high level measurements, On-Time-Delivery (OTD) and non-Conforming Material Return (NCMR) PPM.
  - 4.1.1 On-Time-Delivery (OTD) Definition and Calculation changes:

The measurement is comparing the number of PO lines on time vs total number of PO lines in a certain period, month or quarter. The "on-time" is using the actual material "received date" comparing to the "promise date" in Velvac system. If the received date is the same or earlier than the promise date, it is considered "on-time", otherwise it would be considered "late".

Calculation of OTD OTD% = (# of On-Time PO lines received/Total / # of PO lines received)\*100%

YTD performance monthly trend is also calculated

The OTD goal is 95% or higher. Below is the color code for OTD %.

OTD Metrics

	85%-95%
	below 85%

Note: Supplier on Consignments, Blanket PO or secondary operation are excluded from the above OTD calculations, instead the shortage will be monitored

Velvac communicates most of the non-conforming material to suppliers. Nonconforming means the material does not meet Velvac drawings, specifications or label/packaging requirements. Besides drawings, some of the general requirements can be found on Velvac Website under Library and supplier documents section or Supplier Quality Manual (SQM).

Calculation of PPM PPM = (number of rejected parts/# of total received parts)\*1000000

Note: PPM normally calculated based on a period of three months/quarterly PPM depends on the complicity of the products or commodity. We are more focus on measuring the tread or improvement of PPM based on the previous quarter(s).
